involved in it unless provoked by rash US actions Yet there was no shortage of such provocations the seizure of British merchant vessels bound from one neutral port to another detaining such ships without first conducting a search of their cargo for evidence of contraband of war the de facto blockade of British colonial ports apparent violations of British territorial waters the seizure of British merchantmen off the neutral port of Matamoros Mexico and the use of neutral ports as bases of operations by US warships among them In responding to these and other sources of dispute between the US and Britain Milne proved adept at pouring oil on troubled waters so much so that in a late 1863 letter to Foreign Secretary Lord Russell Lyons lamented his impending departure from the station I am very much grieved at his leaving No change of admirals could be for the better This collection centres upon Milne s private correspondence especially that between him and Lyons First Lord of the Admiralty the Duke of Somerset and First Naval Lord Vice Admiral Sir Frederick Grey It also includes private letters to and from many of Milne s other professional correspondents and important official correspondence with the Admiralty
