The concluding chapters address more specific developments in the field of ICA A number of cases point to the strong perhaps overweening support of the judiciary for arbitration The courts in some jurisdictions support arbitration unequivocally and are bent upon a single outcome no matter the impact on doctrine Lawyer presence in the arbitral process has lead to increased formalization in some proceedings The judicialization of arbitration tilts the process toward the protection of rights and hinders its ability to
