

Features/Elements of Public Sector Reforms

P&Rs have focused on the following five features or elements. They are:

- the redefinition of the role of the state, which includes the principle of subsidiarity;
- efficiency measures such as improved financial and human resources systems to enhance public management performance;
- financial management that includes budget reforms, the introduction of the medium and expenditure framework (MTEF) and tax administration such as the creation of semi-autonomous revenue agencies;
- improved service delivery through surveys of service delivery, quality charters and programme evaluation;
- enforcing accountability through internal and external control mechanisms such as internal audits, code of ethics, developing capacity of supreme audit agencies and improving the independence of the judiciary, legislative and civil society organizations.

A new element has been introduced which some scholars have referred to as the “new public service, serving rather than steering”
