what we should say about them Clear cases of coercion for example involve the threat of significant physical harm But what should we say about cases involving the threat of harms that are relatively insignificant or that involve no physical harm at all Impersonating someone's spouse to trick them into saying yes to sex is clearly very wrong but what about the more mundane kinds of lies people tell when they re trying to meet someone It's wrong to have sex with someone who says yes when they re so drunk they re about to pass out and not wrong if they say yes after having a few sips of beer What though should we say about the more difficult cases in the middle where it s genuinely unclear whether they ve had too much to drink What s the most reasonable view about other forms of incompetent consent to sex like those involving young children elderly dementia patients or people born with severe and permanent cognitive impairments And what about cases of problematic sexual consent that don't involve coercion deception or incompetence at all Can a patient give valid consent to sex with their therapist Can the offer of a large amount of money in exchange for sex invalidate the sexual consent the offer elicits Boonin offers a variety of clear and at times surprising answers to these and other questions about unclear cases in an engaging discussion that should be of interest to students and scholars as well as to anyone else who is concerned with problematic sexual consent Preclinical and clinical issues in Alzheimer's disease drug research and development Cesare Mancuso, Silvana Gaetani, 2015-03-03 Alzheimer s disease AD is a chronic neurodegenerative disorder characterized by progressive cognitive dysfunction and memory loss inability to perform the activities of daily living and mood disorders According to the so called amyloid cascade hypothesis amyloid peptide A produced by beta and gamma secretase mediated cleavages of the amyloid precursor protein APP plays a pivotal role in the pathogenesis of AD A was also shown to contribute to AD pathology by stimulating the hyperphosphorylation of tau which is responsible for the formation of neurofibrillary tangles However the amyloid cascade hypothesis was challenged by other theories which lend support to the idea that A is not causative but can be considered as an innocent bystander in AD Although preclinical research generated impressive lines of evidence about the several intracellular mechanism s whose impairment leads to the onset and progression of AD clinical research aimed at the development of new drugs capable of preventing or delaying the onset of neuronal damage in AD patients has produced limited results The drugs currently available for the treatment of AD are acetylcholinesterase inhibitors AChEI and the NMDA glutamate receptor antagonist memantine The AChEI increase acetylcholine levels in the synaptic cleft which are reduced because of the progressive damage of cholinergic neurons in cognitive brain areas e g amygdala hippocampus and frontal cortex whereas memantine is used to prevent reduce calcium dependent excitotoxic neuronal cell death Both classes of drugs have been shown to improve symptoms related to cognitive decline but their effects are confined largely to patients with mild to moderate AD in particular during the first year or so of treatment An alternative to this symptomatic treatments involves the use of drugs that intervene in the pathogenesis of the disease Recently monoclonal antibodies against A were proposed as novel agents capable to remove A from the brain thus preventing neuronal
