Human Rights:

- **First Generation:** Rights individuals have simply by being human beings
 - Ex. Life, freedom from physical harm, speech, assembly, press, religion, due process
 - Civil Liberties
- **Second Generation:** Material and economic rights that apply to entire society
 - Ex. Education, food, employment, shelter, health care
- **Third Generation:** Rights needed to protect minorities or unpopular groups from oppression of majority
- ***Importance to Terrorism:**
 - French v. FLN (Algeria): Crackdown on FLN supporters and vene on ordinary Algerians, turned Algerian people against France, turned some French people against occupation
 - Kurds (Turkey): Imprisoned PKK activists and ordinary Kurds in a terrible prison, became known as the PKK University, turned ordinary Kurds into PKK supporters and fighters
 - Egypt: Assassination of Anwar Sadat following Camp David Accords, leading to mass arrests of assumed assassin associates and marshal law until 2011
 - 9/11 (United States): Some accusations that U.S. policy following 9/11 leads to human rights violations
 - Bush: Patriot Act (Relaxed restrictions on surveillance); Warrantless Wiretapping; Extreme Rendition and CIA Black Sites; Camp X-Ray at Guantanamo Bay; Bybee Memo on Interrogation (Description on legal barriers and point of entry for enhanced interrogation techniques against suspected terrorists- found so long as the person will not die, or experience failure of a major organ, it is legal)
 - Obama: Outlawed torture, provided retroactive immunity to interrogators; continued Patriot Act; did not close Guantanamo Bay; Used drones; engaged in targeted assassinations
 - Trump: Talked about returning to torture or enhanced interrogation techniques (stated that "torture works"); Talked about killing terrorist family members; Promoted Gina Haspell to Head of CIA (worked on black-sites) (controversial); Targeted assassination of al-Baghdadi (criticism of extrajudicial killing)
 - Biden: So far has issued an executive order to reduce the use of drones and reduce civilian casualties.
