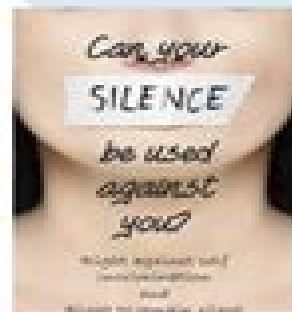


Right to Remain Silent

Context: The Supreme Court of India has emphasized that all accused individuals have the **right to remain silent and cannot be forced to speak or admit guilt.**

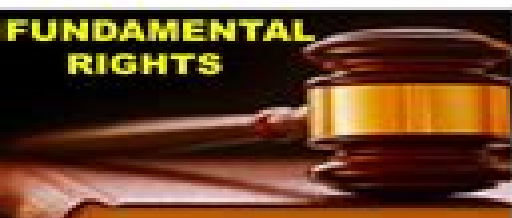


What is the Right to Remain Silent?

The right to remain silent is a **legal principle** that allows individuals to refuse to answer questions or provide information to law enforcement or during legal proceedings **without facing negative consequences**

Observation of SC

Cooperation with an investigation does not equate to **confession**, and an accused person's choice to remain silent cannot be considered non-cooperation. An accused's decision to remain silent should not absolve the prosecution from proving guilt beyond a reasonable doubt.



Right to silence is derived from **Article 20(3) of the Indian Constitution (fundamental right)**, which prohibits compelling a person to be a witness against themselves.

Exceptions:

The Protection limited **only to criminal proceeding**. Right is not available to a person who is being interrogated under **Customs Act, 1962, or Foreign Exchange Management Act, 1999**, since the person is not **"accused of an offence"** and isn't entitled to a lawyer.
