In traditional approaches to legal certainty law is regarded as a hierarchical system of rules characterized by stability clarity uniformity calculable enforcement publicity and predictability However the current reality is that national legal systems no longer operate in isolation but within a multilevel legal order wherein norms created at both the international and regional level are directly applicable to national legal systems Also norm creation is no longer the exclusive prerogative of public officials of the state private actors have an increasing influence on norm creation as well Social scientists have referred to this phenomenon of interacting and overlapping competences as multilevel governance Only recently have legal scholars focused attention on the increasing interconnectedness and
