pursued the full set of market oriented reforms while others retained a more important role for the state Third reform efforts should be driven and tailored to desired policy outcomes and less preoccupied with following a predetermined process particularly since the twenty first century agenda has added decarbonization and universal access to power sector outcomes The Washington Consensus reforms while supportive of the twenty first century agenda will not be able to deliver on them alone and will require complementary policy measures
