

ROSENBERGS DIE IN CHAIR

Enemy Asks Talks Recess

WUSHAN, Saturday, June 26.—The Communist Saturday demanded immediate recovery of 24,000 North Korean prisoners of war based on order of President Syngman Rhee and asked for an indefinite recess in the Korean armistice negotiations.

Their demand was made in a plenary session at Posenung in a strongly worded protest which charged that the United Nations Command "deliberately deceived with Rhee to free the prisoners."

"The United Nations must bear the same responsibility for the Rhee," said the Communists' press.

The first protest did not break all the tension which has been a ruling factor in the progress of a five days ago for the armistice talks.

North Korean people asked for Rhee's release, pardon and aid.

Convicted Spies Refuse to Talk

NEWARK, N. Y., June 26.—Julius and Ethel Rosenberg, silent and without emotion, died in the electric chair Friday night for betraying atomic secrets to Russia.

Julius, looking frail and unsupported by guards, entered the long dingy death chamber first, at 11:45 p.m. (E.S.T.) as a chaplain touched the steel pedal by his side. Two minutes later he was pronounced dead.

His wife was then led in, at 11:50, and she was dead at 11:55, less 20 minutes before the last hour of the sitting was followed by the start of the morning session.

Their deaths ended a 10-month tour of dramatic legal maneuvers after the Supreme Court had issued a stay of execution previously granted.

The Rosenbergs were the last prisoners in American history to die by electrocution.

The day's dramatic finale to end the espionage case was the execution by hanging in prison in Washington, D.C. and New York for atom spies after the Supreme Court.

5,000 Scream About Death

NEW YORK, June 26.—A 10-minute, heart-rending throng of more than 5,000 crowded on their feet and began singing as Julius and Ethel Rosenberg died.

A woman fell to the pavement, screaming with her arms outstretched. Another woman fainted, and two women died.

Thousands of people stood on the roof of the prison, and the roof was covered with the dead.

Some were shouting "No more atom spies!" and others were shouting "No more atom spies!"

"Ethel and Julius Rosenberg are now in the execution chamber," the warden said, the people of the crowd began to cheer. The
