The kind of detailed phonetic description required for instance to synthesize natural sounding speech or to provide a background for clinical studies in a language is well beyond the scope of a single study but it is necessary to begin this greater work with a fundamental description of the sounds and supra segmental structure of the language. In keeping with this the goal of this project is to provide a baseline description of the phonetic structure of Navajo as it is spoken on the Navajo reservation today to provide a foundation for further work on the language.
