Al estudiar los distintos tipos de contratos fiduciarios regulados en Colombia así como los productos y servicios que a partir de ellos se ofrecen en el mercado se constata que en todos la relación jurídica entre el cliente fideicomitente fiduciante o constituyente y el prestador de los servicios fiduciario da lugar a derechos a favor de aquellos así como a favor del beneficiario o fideicomisario.
