

Constitutional Convention

- The constitutional framers balanced two dangers: government that was too strong (the king of England) versus government that was too weak (the Articles of Confederation).
- The debates focused on five central issues:
 - Should the people be directly involved in government? Most delegates believed in filtration, or indirect elections.
 - National versus state power, which came down to a standoff between larger and smaller states. Led by Madison, the big states introduced the Virginia Plan. Small states countered with the New Jersey Plan. The Connecticut Compromise offered a solution: House members were elected on the basis of population, but every state had two Senate seats.
 - The nature of the presidency.
 - How best to separate powers, answered through a system of checks and balances. For the most part, these limits on concentrated authority would continue to develop long after ratification.
 - Slavery: Pragmatic compromise overcame moral concerns. Delegates took care not to use the word *slavery* in the Constitution, but several clauses enabling the institution to grow and expand would lead to the greatest conflict in the nation's future.
