Reynolds, 2017-05-08 In *Maintaining Segregation* LeeAnn G Reynolds explores how black and white children in the early twentieth century South learned about segregation in their homes schools and churches As public lynchings and other displays of racial violence declined in the 1920s a culture of silence developed around segregation serving to forestall absorb and deflect individual challenges to the racial hierarchy The cumulative effect of the racial instruction southern children received prior to highly publicized news such as the *Brown v Board of Education* decision and the Montgomery bus boycott perpetuated segregation by discouraging discussion or critical examination As the system of segregation evolved throughout
