improve these levels The Department for Education had a particularly poor performance and evidence was taken from the Parliamentary Under Secretary and a senior official in the Department which the Committee found unsatisfactory with and so a follow up session with the Permanent Secretary and Secretary of State was undertaken The Committee will continue its interest in the answering performance of this Department and hold it to further account should its performance not improve markedly
