# FAIR HEARING: DUE PROCESS PROTECTIONS FOR MEDICAID BENEFICIARIES

- All hearings must be held at a reasonable time, date, or place
- The Beneficiary must be given the opportunity to examine, at a reasonable time before the date of the hearing
  - the contents of their case file, and
  - all records or documents to be used by the state

### The Beneficiary has the right to

- Bring witnesses
- Establish all pertinent facts and witnesses
- · Present an argument without undue interference
- Question or refute any testimony or evidence, and cross examine adverse witnesses
- Submit documentary evidence before, during, or after the hearing
