

Tackling Violence Against Women and Girls in Sport



Strategies and Recommendations for a Safer Playing Field

Male violence against women and girls is one of the most pervasive human rights abuses in the world today. It is rooted in gender inequality, discrimination and harmful social norms that emphasize men's superiority over women and normalizes violence towards women and girls. Sport both reflects and magnifies broader social hierarchies and patterns of discrimination. At the same time, it can serve as a powerful tool to challenge toxic stereotypes and drive equality outcomes. UNESCO's sport flagship, Fit for Life, works in and through sport to upend the root causes of male violence against women and girls in collaboration with partners from public, private and sport sectors. Its focus is twofold: to promote and enhance survivor-centered policies and regulatory frameworks which prevent and respond to violence, and to engage with athletes, coaches, and other members of the sports community, empowering them to recognize and end it.

The problem: the scope of male violence against women and girls in sport

One in three women worldwide has faced some form of physical or sexual violence in her lifetime, and athletes are no exception. Across all sports and all continents, female athletes face significant risks of abuse. Traditionally male-dominated environments, combined with ineffective governance structures, a lack of transparency, and the prioritization of sport profits over individual well-being contribute to deeply rooted power imbalances, negative gender stereotypes, and the normalization of abusive practices and cases of violence.

Violence in Sport

- 21% of female athletes experienced a form of child sexual abuse at least once in their sport careers
- 31.8% of female athletes reported having been punished via excessive training or exercise
- Female athletes were the target of 87% of online abuse on Twitter during the 2020 Olympic Games in Tokyo

Addressing the prevalence of violence in sport and ending impunity requires concerted, collective action, underpinned by solid legislative frameworks that provide clear routes for the prosecution of perpetrators while supporting and protecting survivors. This can be challenging – coaches and other athlete entourage often lack comprehensive education on recognizing and addressing violence, and policy makers wishing to act on it must navigate complex, multi-stakeholder sport ecosystems. Cases of male violence against women and girls in sport remain significantly underreported due to a lack of clear and effective reporting processes, a fear of retaliation, and a general mistrust of existing mechanisms. When reports have surfaced, they have often been met with inaction or insufficient response, leaving survivors of violence with no clear route to remedy — and, in many cases, worsening their situation considerably while offenders walk free.

The solution: strategies for change

Despite the challenges, there are numerous opportunities to address violence against women and girls in sport, provided that sports practitioners, policy makers, media stakeholders and actors from civil society work together. To advance this joint effort, UNESCO, UN Women and the Spotlight Initiative have developed "Tackling Violence Against Women and Girls in Sport: A Handbook for Policy Makers and Sports Practitioners" which furthers a common understanding of the problem, provides tools to address violence and proposes areas for effective collaboration.

Sport as a Change Agent

- Participation in sports can increase girls' confidence by as much as 80%
- 94% of coaches report that their athletes seek their support regarding personal problems
- The presence of other female role models in sports organizations makes female coaches 4 times more likely to remain in their jobs
- After participating in team workshops on sexual and reproductive rights with Futebol do Forpo, 81% of girls felt that their football team was a safe space

Have women been denied access to gynaecological treatments during the lockdown including safe abortion and if so with what impact on their health and wellbeing has the female work force suffered disproportionately in economic terms? Have national and international recommendations and policies been sufficiently gender neutral? Have breastfeeding rates been adversely affected? Will COVID 19 make attainment of the UN SDGs more difficult etc?
