Cardiac

- Cardiac output is the volume of blood in liters pumped by the heart in 1 minute, normal range 4-8L/min
 - $CO = HR \times SV$
 - Ejection fraction is the % of blood ejected with each heartbeat (Normal 55-65%)
 - Systemic vascular resistance (SVR) is the resistance in the systemic vascular bed. The resistance to blood flow
 - Peripheral vascular resistance (PVR) is the resistance of the pulmonary vasculature
 - Preload- is the volume of fluid within the ventricle at the end of diastole
 - Afterload- is the forces opposing ventricular ejection; the amount of resistance the heart must overcome for the next contraction
 - MAP is the Mean Arterial Pressure- the average BP during one cardiac cycle, normal range >60-65; to get MAP it is $SBP + 2(DBP) / 3$
- ❖ Stable angina is where pt can get relief of chest pain with rest (last only a few min or less with rest and usually predictable)
- ❖ Unstable angina is chest pain that is unrelieved with rest, unpredictable and last longer than 10 min
- Medication to give to pt. with angina is NITROGLYCERIN
 - Educate patient that to take 1 pill Q5 min X3 under tongue and dissolve; store in dark room temp space and that it causes hypotension and HA
 - Labs for acute MI include Troponin (most reliable), CK-MB, BNP (normal <100), CRP, myoglobin

Heart failure

- ❖ CM of right-sided HF

*STUDY TIP REMEMBER SWELLING WITH RIGHT SIDE HF

- Peripheral edema, wt. gain, enlarged liver, JVD, lethargic, tachycardic, dysrhythmias, nocturia, ascites

- ❖ CM of left- sided HF

*STUDY TIP REMEMBER THEY'RE DROWNING

- Dyspnea, crackles in lungs, weakness, orthopnea, nocturnal paroxysmal dyspnea, tachycardic, murmur (S3 heart sound), nagging cough, wt. gain

Dysrhythmias

- ❖ Difference between cardioversion and defibrillation:
- Cardioversion you **SYNCH THE RHYTHM** before shocking
 - Rhythms to cardiovert include A-FIB, SVT, V-TACH WITH PULSE
 - Defibrillation you **JUST SHOCK, NO SYNCHING**
 - Rhythms to defib V-TACH WITH NO PULSE & V-FIB
