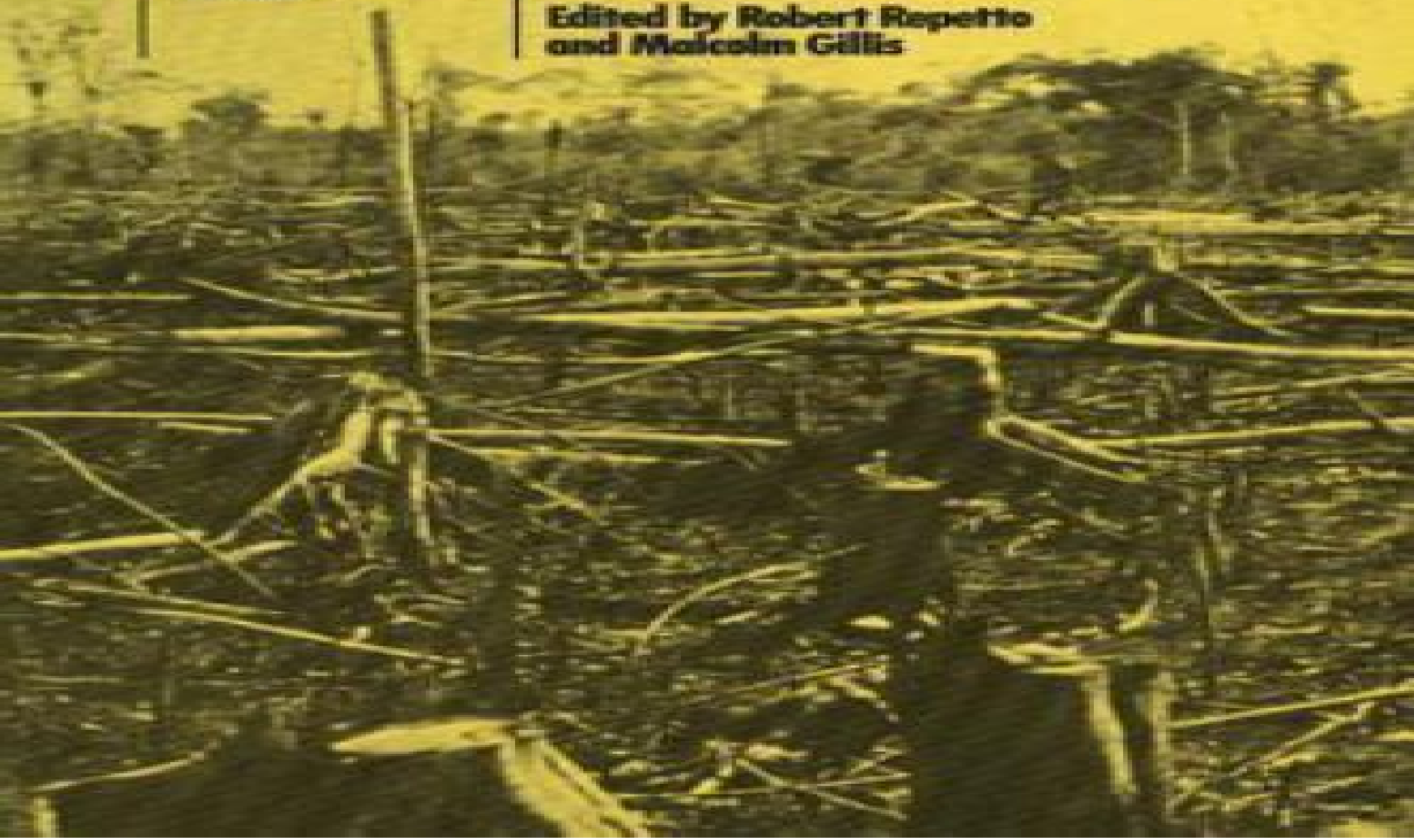

in conflict with each other can be significant On the other hand where fundamental changes in forest policy such as tenure

and forest revenue reform are needed certification should not be seen as a substitute for these A further conclusion is that while public policies change over periods of decades the private policies of retailers and forest product companies can adapt more rapidly to changing circumstances The concept of a fast track of private policy change compared to the slower track of governmental policy change is therefore proposed and described A number of interesting theoretical and empirical avenues for further research on certification are discussed
