De entre las muchas modificaciones destaca la reforma del trámite de admisión del recurso de amparo vertebrado ahora por un tenor positivo y objetivo en la línea de jurisdicciones constitucionales de referencia como el Tribunal Supremo Federal de los Estados Unidos de América y el Tribunal Constitucional Federal alemán. Ambas experiencias jurisdiccionales constituyen un cualificado referente para un desarrollo del nuevo trámite de admisión del recurso de amparo que aspire a contribuir a la descarga del Tribunal Constitucional y a la reordenación de su tiempo y de sus recursos conforme a la importancia de los asuntos planteados. Tomando en cuenta los principales aciertos y advirtiendo de los riesgos y errores de ambas experiencias sin perder de vista las particularidades de nuestro ordenamiento jurídico, la presente obra propone un trámite de admisión que permita al Tribunal Constitucional centrarse en los casos con especial trascendencia constitucional con un procedimiento sencillo y fluido. El presente trabajo sinopsis de la tesis doctoral del autor está dirigido no sólo al ámbito académico en materias de Derecho Constitucional, Procesal Constitucional y Derecho Comparado, sino también a la práctica forense ya que el desarrollo propuesto tiene una clara aplicación práctica en la elaboración de recursos de amparo. Mario Hernández Ramos, doctor con mención Doctor Europeus y premio extraordinario de Doctorado, es profesor del área de Derecho Constitucional de la Universidad de Salamanca.
