now only an SEZ called the Rason ETZ is under operation but it has never been an economically bustling place North Korea still has a plan to open a number of SEZs and economic development zones sometime in the future All these matters are discussed in this book People may have a question if North Korea has a robust and reasonable mechanism to facilitate the business of foreign investors In order to bolster the open door policy North Korea has enacted dozens of laws and made scores of implementing regulations At the beginning stage these laws and regulations had a lot of flaws because this country has never experienced market oriented activities Since then North Korea has made constant efforts to address flaws and contradictions in laws and regulations but without restructuring the mechanism of socialistic economy In relation to the business environment issues in foreign exchange banking system transfer of technology labor tax customs immigration land tenure expropriation political risk insurance are analyzed and discussed What about dispute settlement mechanism in North Korea These questions are naturally raised by foreign investors and trade counterparts North Korea has judicial and alternative dispute settlement system but question is about fairness and due process In fact the same question has been raised in China and other economies in transition since their socialistic judicial mechanism and legal concept differ from the other world This book reviews all these questions and suggests solutions Implementation of North Korea s open door policy has functional relations with international politics The United States starting at the breakout of the Korean War until now and the United Nations Security Council in recent years have imposed heavy economic sanctions on North Korea Because of these North Korea ascribes to the United States the stagnation of its economy It may be true at least in part but it is not all the cause of North Korea s economic woes Rather the key for solution resides inside the nation This book suggests takeaway points North Korea has to bear in mind for further journey For readers convenience and understanding better North Korea s Socialist Constitution as recently amended and most updated seventeen statutes relevant to foreign direct investment and trade are loaded in the Appendix
