PETER CLAIMS TO HAVE SEEN JESUS ALIVE

Jesus the prophet from Galilee who was executed on Friday for rebellion against Rome has been seen alive around Jerusalem, according to about 20 of his followers.*

Peter, the new leader of Jesus' band, is said to have been the first to see Jesus alive since his crucifixion. Disciples of Jesus say that Peter was alone when Jesus appeared to him, in the Jerusalem area on mid-Sunday morning.

(Peter came to a position of prominence among Jesus' followers when he claimed some months ago that Jesus was the long-awaited Jewish Messiah.)

First news of Jesus' return from the dead came from several Galilean women loyalists who claimed to have found the tomb opened early Sunday morning and occupied by 2 men dressed in white. They had gone to the tomb to anoint and treat the body even though it had been dead for 40 hours by this time. The men, they said, rebuked them for being there, telling them that they ought to have known that Jesus would no longer be dead. They reminded them that Jesus had told them while he was still in Galilee that he would rise from the dead within days. The women did not see Jesus.†

These women, led by Mary Magdalene, returned from the cemetery and told the leading 11 followers of Jesus of their experience with the 2 men.

These 11 followers did not believe the women. Peter, however, did go to the cemetery to investigate the state of the tomb where Jesus had been buried early Friday evening. He did not see the two men that the women claimed to have seen, but did claim to see the grave-clothes of Jesus neatly folded. It appeared that whoever took the body had not been in any haste.

Peter then left the tomb and it was some time after this while he was alone that he said Jesus appeared alive to him.



When Jesus appeared to his followers on Sunday, he attempted to prove that he was as much flesh and blood as they were by telling them to touch him, and then by eating some fish with them.

Peter told the other 10 leaders of Jesus' followers, and they all believed Peter's report, even though none of them claimed to have seen Jesus. Peter's report was sufficient to convince them that their executed leader had indeed come back from the dead.‡

Two other disciples of Jesus later reported to the eleven leaders that they had also seen Jesus alive. The 2 said Jesus had walked with them along a road-way without either of them recognizing him. They said they only knew his identity when he began a meal with them. Only at the moment he gave them the bread, they said, did they recognize him as Jesus. At the moment of recognition, however, they claimed that he vanished into thin air.

While these 2 disciples were reporting their experience to the 11 who already believed Jesus was alive as a result of Peter's claim, Jesus suddenly appeared among them in the room.

The 11 followers, however, were terrified at what they thought was a ghost, and could not accept that it was Jesus. It appears that they only came to believe it was Jesus when they touched him and saw him eat as a fellow flesh and blood human being.□

DISCIPLES WAIT IN JERUSALEM FOR MISSION

Since Jesus is said to have appeared to Peter and then his ten other leading Galilean followers, they have remained in Jerusalem waiting for the arrival of a heavenly power to equip them for the mission of proclaiming salvation from sin to all nations.

Jesus is said to have appeared to Peter and then the other close disciples in and around Jerusalem on the Sunday after his execution on Friday.

Peter saw Jesus soon after visiting his tomb. Two other disciples then saw him on the road to Emmaus just outside Jerusalem. Finally the other inner circle of leading loyalists say he appeared to all of them in Jerusalem.

At this meeting late on Sunday, Jesus told his Galilean followers that they were not to leave Jerusalem at all, but were to stay in the city until they received a special power from heaven that would equip them to announce a message of salvation from sin in the name of Jesus among all nations. §

40 days later, Jesus' followers claim, they saw him carried into heaven on clouds. This happened not far outside Jerusalem.

His followers then returned to Jerusalem where they continue to wait for the promised power from heaven.

They pass their time waiting for this power by daily visits to the Temple.

They believe that when this power comes that they will then be in a position to carry out Jesus' command to be witnesses of Jesus around the world.

The first place where they are to publicize Jesus is in Jerusalem itself.¶ Only after this power comes, they say, will they leave Jerusalem and fan out to the regions of Samaria and Galilee and beyond. Until then, Jerusalem waits.□
