its Vice Chair The statute directed the Commission to develop a plan for the establishment implementation and financing of a comprehensive coordinated and high quality system that ensures the availability of long term services and supports for individuals in need of such services and supports including elderly individuals individuals with substantial cognitive or functional limitations other individuals who require assistance to perform activities of daily living and individuals desiring to plan for future long term care needs The statute further directed the Commission within 6 months of the appointment of Commissioners by September 12 2013 to vote on a comprehensive and detailed report based on the long term care plan described above that contains any recommendations or proposals for legislative or administrative action as the Commission deems appropriate including proposed legislative language to carry out the recommendations or proposals
