Radioactive Waste Disposal at Sea Lasse Ringius, 2000-11-20 Most studies of environmental regimes focus on the use of power the pursuit of rational self interest and the influence of scientific knowledge Lasse Ringius focuses instead on the influence of public ideas and policy entrepreneurs.
