gone down Nursing home operators contend that they are victims of excessive regulations and costly unfounded lawsuits and that Medicaid's rates for nursing home care fall about 25 per patient day or collectively about 7 billion per year below the cost of providing proper care Residents are still in jeopardy some of the same conditions are reported decade after decade William grew up in a dysfunctional family as many of us do He had a strained relationship with his mother largely because of a ruthless 13 year scorched earth divorce war that she waged against his father who was a steelworker As Mary Regina grew older she lived in Pittsburgh Pennsylvania and William lived 1 775 miles away in Las Cruces New Mexico When William's sister died young he became his mother's sole surviving offspring And after Mary Regina broke her hip William traveled to Pittsburgh and spent 20 days standing by at her bedside in a skilled nursing home He observed what happened on the day shifts and listened as Mary Regina told him what happened at night William's complaints about the nursing home to the state department of health were not handled satisfactorily so he began researching this book
