framing of reflective practice which had not existed prior to this study and reflective practice was fundamental in assessing the impact of clinical legal education on students and teachers in the development of professional skills and social values and communities in addressing legal needs Teaching clinically was seen as reflective teaching which holistically integrated critical reflection reflection in action and reflection on action and created space for the role of emotions and relational learning in legal practice Law clinic practice evoked deep emotions for students when exposed to societal harms and the criminal justice system The study however indicated that reflective practice was implicitly an integral part of clinical legal education that needed to be made more explicit through increased documentation of processes to promote transferability of knowledge and practice in legal education The study provided a theoretical guide in framing and supporting a framework for an expansive concept of reflective practice for clinical legal education and for the legal profession
