Reforming the Military Retirement System ,1998 This report applies the models developed in earlier RAND reports Asch and Warner 1994A 1994B to analyze the effects of converting the military retirement system to a system very similar to the Federal Employees Retirement System FERS which is the system that covers federal civil service employees The authors analyze several versions of this system named the Military Federal Employees Retirement System or MFERS To compensate for the mandatory contributions MFERS would be coupled with a pay raise To the extent that the MFERS system failed to create the retention and separation patterns needed to achieve the services desired seniority profiles it would also include a system of retention bonuses and or separation payments The authors consider the implications of this proposal in terms of the effects on cost force size and structure productivity and force management flexibility **Reforming the Military Retirement System** Beth J.
