it argues that considerable amounts of existing company law theory which is ostensibly built from agency theory is in fact based on a series of hidden value judgments at each stage of the analysis Fourth it argues that company law theory should use agency theory less to rebalance the discipline agency theory has become hegemonic which is dangerous for the discipline obscures company law s role in establishing incentives undermines accountability and reduces company law s autonomy The book then moves to the logic of agency theory and makes three arguments First it argues that we need to factor in the company only apply agency theory to voluntary interactions and foreground our value judgments when identifying agency relations to do it properly Second it argues that it is rational to incur agency costs when we perceive the benefits of doing so to outweigh the costs meaning that agency costs can be facilitative and we should look to front end them rather than universally minimise them Third it argues that this needs to be undertaken through mandatory laws Exploring the external limits and internal logic of agency cost analysis this book will be of interest to academics students and researchers of corporate and company law
