**Somali Piracy** Jade Lindley, 2016-06-23 Maritime piracy off the coast of Somalia was first recognised as a global concern in 2008 after the hijackings of World Food Programme vessels. It remains a serious impediment to international maritime trade and a significant risk to seafarers. In contrast, the reality in low and middle-income countries (LMICs) is strikingly different, where disparities in accessibility to these technologies exist. The high cost of genomic sequencing and other molecular technologies remains a limiting factor in the common implementation of these methods for diagnosis and research of rare diseases in resource-limited settings. The study of rare genetic diseases in LMICs may be underestimated.
