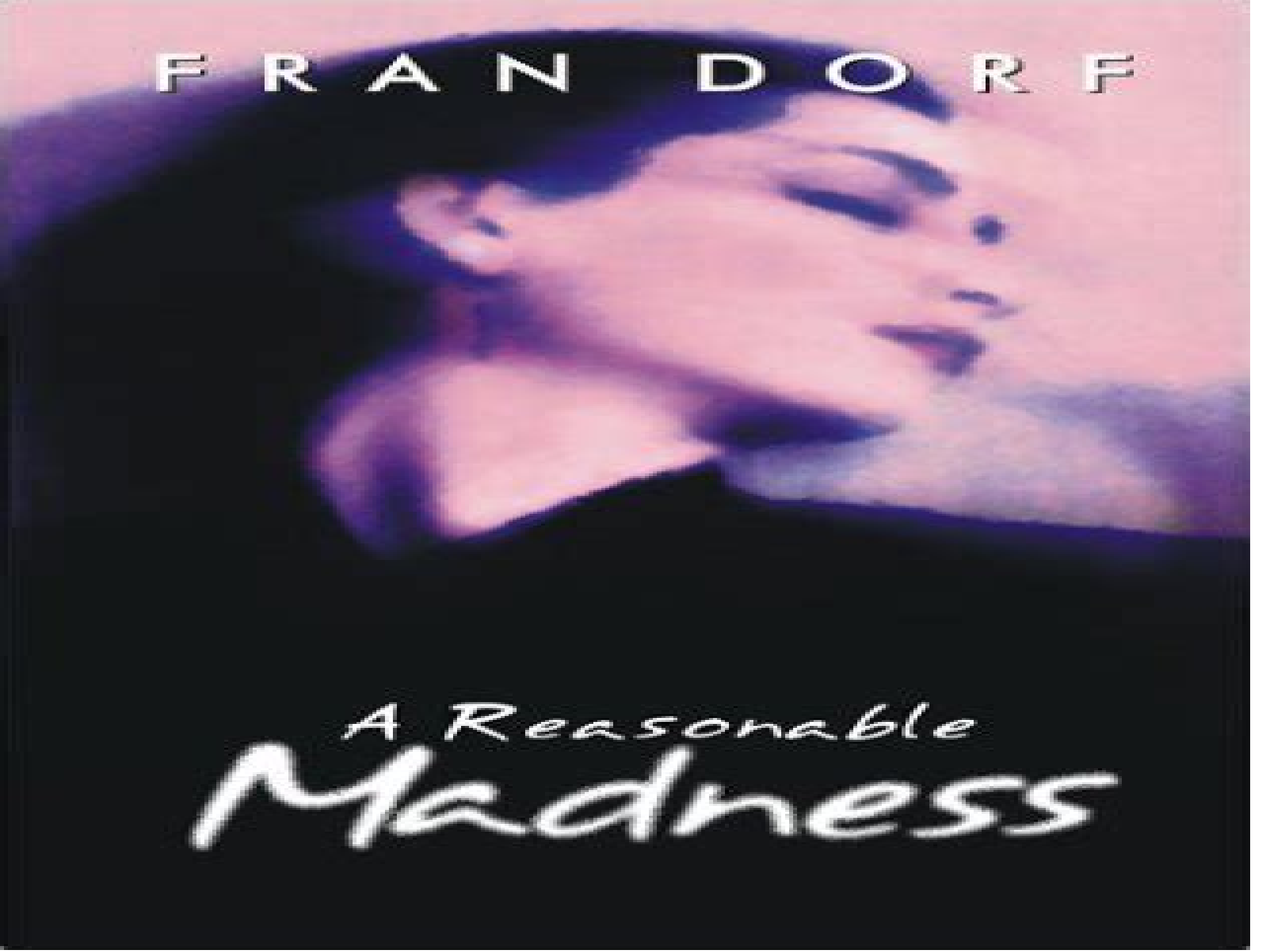

Reasonable Madness:

Foucault's Nietzschean Genealogy Michael Mahon, 1992-01-01 This is the first full length study of the impact of Friedrich Nietzsche's writings on the thought of French philosopher Michel Foucault. Focusing on the notion of genealogy in the thought of both Nietzsche and Foucault, the author explores the three genealogical axes: truth, power, and the subject as they gradually emerge in Foucault's writings. This complex of axes into which Foucault was drawn especially as a result of his early history of madness called forth his explicit adoption of a Nietzschean approach to his future work. The work concludes with an analysis of Foucault's final writings on the genealogy of modern subjectivity and an examination of how truth, power, and the subject operate for the modern psychoanalytic subject of desire.
