With the Writers House as a prism, National Socialist Cultural Diplomacy also offers a case study of the fault lines that emerged in the Nordic literary sphere with the post-1933 ideologization of the German literary field, its institutions and its lucrative book market. At stake was the role and identity of the literary intellectual, the proper relationship between culture, economics and politics and for some of the visiting writers whether to place consciousness over comradeship.
