Scholl, 2017-10-18 This book presents twelve essays by historian David M Williams in order to pay tribute to his career The essays stretch from 1807 through to the end of the nineteenth century and address both economic and social themes Topics include maritime trade deployment of merchant ships the state regulations concerning shipping shipwrecks and loss of life passenger cargoes slavery cotton timber and coffee trades and the working conditions of seamen over the course of the century The plight of the maritime labourer is at the core of this collection The essays primarily focus on British shipping and firmly places it within an international context The book is introduced by Lars U Scholl followed by two tributes to Williams career one by Peter N Davies the other by Lewis R Fischer Scholl concludes the volume with a thorough bibliography of Williams maritime writings books chapters and articles **Maritime Labour** Richard Gorski, 2007 This is a collection of soundings into various aspects of the history of maritime labor from the close of the Middle Ages to the present The spatial emphasis of the essays is north European and Atlantic since they deal with the countries around the North Sea and Baltic with some coverage of North America Indeed from time to time the authors leave the sea behind in order to examine broader issues such as labor markets the regulation and institutions of seafaring and industrial relations on the waterfront But at all points there is a common theme of sea related labor and a common objective of better understanding what have often been perceived as difficult and elusive groups of people International Merchant Shipping in the Nineteenth and Twentieth Centuries Lewis R. Fischer, Even Lange, 2017-10-18 This book compiles seven essays concerning changes to merchant shipping over the hundred and fifty years between 1850 and 2000 and spanning a range of countries with particular focus on Norway Greece Japan and England The essays are linked by the theme of change from traditional to modern shipping in fluctuating cargo demands from sail to steam wood to iron in improvements in communication technologies in political natures and affiliations in seafaring skillsets in the advent of containerisation and advent of globalisation The overall aim is to construct a solid international context for the merchant shipping industry in the nineteenth and twentieth centuries primarily to aid a major Norwegian deep sea merchant marine project The book contains an introduction that sets out these aims and seven essays by maritime historians which form part of the international contextual whole though all can be approached individually *Oceania under steam* Frances Steel,2017-02-01 The age of steam was the age of Britain's global maritime dominance the age of enormous ocean liners and human mastery over the seas The world seemed to shrink as timetabled shipping mapped out faster more efficient and more reliable transoceanic networks But what did this transport revolution look like at the other end of the line at the edge of empire in the South Pacific Through the historical example of the largest and most important regional maritime enterprise the Union Steam Ship

Company of New Zealand Frances Steel eloquently charts the diverse and often conflicting interests itineraries and experiences of commercial and political elites common seamen and stewardesses and Islander dock workers and passengers Drawing on a variety of sources including shipping company archives imperial conference proceedings diaries newspapers and photographs this book will appeal to cultural historians and geographers of British imperialism scholars of transport and *New Directions in Norwegian Maritime History* Lewis R. mobility studies and historians of New Zealand and the Pacific Fischer, Even Lange, 2017-10-18 This book is a wide reaching study of Norwegian maritime history and developments within the discipline It brings together the research efforts of a University of Oslo project aiming to further understand Norwegian shipping history between 1814 and 2014 and the work of a new generation of maritime historians Structured into three sections global integration political issues and success and failure the volume covers a broad range of maritime topics that have influenced both Norwegian economic development and Norwegian cultural identity Through analysis it discovers that in the last few decades Norwegian shipping has been plaqued by multiple troubles whilst simultaneously becoming less crucial to the Norwegian economy in favour of offshore petroleum production However it reiterates the historical importance of shipping to the economic development of Norway and asserts that historians have begun to treat it as the centre from which other industries grew Maritime Transport and Migration Torsten Feys, 2007 This study explores the connection between global maritime and migration networks to better understand the acceleration of the transatlantic migration rate that took place in the latter half of the nineteenth and early twentieth century It brings together the actions of migrants government regulators transatlantic shipping companies and the agents who represented them to determine the motives and opportunities for transatlantic mass migration The study is comprised of an introductory chapter seven essays by maritime scholars and a conclusion The subject is approached from three particular discussion points the rate of development and the accessibility of transport networks for European migrants the competition between shipping companies and the subsequent influence on migration and the integration of labour markets in both Europe and America It concludes by suggesting both maritime and migration historians should merge their respective fields by including the larger frameworks of each discipline to gain further understanding of their disciplines and identifies the role of ports and shipping companies as crucial to any further study of mass migration New Directions in Mediterranean Maritime History Gelina Harlaftis, Carmel Vassallo, 2017-10-18 This study seeks to correct the underrepresentation of Mediterranean maritime history in academic publications in attempt to understand the multi cultural and multi ethnic environment in which maritime activity takes place by compiling ten essays from maritime historians concerning Spain France Italy Malta Slovenia Greece Turkey and Israel The aim of the collection is to provide an insight into Mediterranean maritime history to those who could not previously access such information due to language barriers or difficulty securing non English publications some of the essays have translated into English specifically for this publication The majority of the essays concern the Early Modern period and the remainder

The second section contains the remaining four essays which consider port systems from national perspectives The Rescue of the Third Class on the Titanic David Gleicher, 2017-10-18 This work seeks to understand why a disproportionately large number of third class passengers particularly women and children died during the sinking of the Titanic in relation to the first and second classes It examines the gender class social and cultural factors that influenced this disparity It aims to uncover both why and how five hundred and thirty one third class passengers died on the night of April 14th 1912 A key area of focus is the difficult relationship between the ship's authorities and the men of the third class and the extent to which this determined the fate of passengers during the rescue efforts The introduction asks Who were the third class passengers and uses ethnic and economic backgrounds to suggest the third class belonged to the Old Immigration wave of migrants rather than the contemporary New Immigration of the first and second The first chapter concerns the exclusion of third class narratives in the popular story of the Titanic Chapters two through seven determine the whereabouts of the third class during every stage of evacuation and flags the discrepancies in testimonies from both the British and American inquiries Chapter eight provides a conclusion which claims the popular story includes a great many falsehoods with regard to the third class including their treatment by crew their behaviours and their survival rates The first appendix tables nationalities into regions the second outlines the twenty routes to the lifeboats as testified by one of the Titanic design architects and the third provides deck plans for every level of the ship Sail and Steam Lars U. Scholl, Merja-Liisa Hinkkanen, 2017-10-18 This collection provides a tribute to the career of maritime historian Yrj Kaukiainen composed upon his retirement from the University of Helsinki It collects seventeen of his maritime essays written in English reprinted in order to celebrate his career and impact on the field of maritime history.
