Considering the direction of innovation in EU merger control

ABSTRACT

This paper considers the role that innovation plays in EU merger control analysis, and seeks to integrate perspectives highlighted by the philosophical literature on the so-called 'direction of innovation' in order to critically assess the impact of market concentration on the diversity of innovation and its ability to address larger normative questions and challenges, such as the transition to more sustainable economies. While normative goals other than competition are not an inherent part of merger control, this paper argues that in concentrated markets, ignoring such questions can play into the hands of the powerful merging entities, allowing them to further determine the direction of Innovation to best serve their interests and business models rather than public interests. This is illustrated by critically discussing the merger between Bayer and Monsanto as an example.

Introduction

As part of competition policy, merger control appraises concentrations and changes in market structures that often have a significant and long-lasting impact on markets and the development of industries and economies at large. While it is 'not the job of competition law to save the planet' (Khan 2022), both competition and innovation play a considerable role in deciding what the future markets and realities look like. This paper thus looks at the potential interaction of three things: the relationship between competition and market concentration; new perspectives on innovation; and the normative quest to address the sustainable development goals, in particular the counteraction of climate change. It postulates that the future structure of large industries and their innovation potential and diversity can play a large role in achieving sustainability goals. Critically analysing how market structures affect the innovative output and the so-called 'direction of innovation' could be a first step in this direction. This approach represents a diversion from traditional merger control, where market outputs such as innovation are often viewed as driven by market forces alone.

Directionality broadly describes the idea that innovation is not a blind or indeterminate process but that is can be the outcome of certain economic policies and market conditions.
