

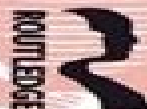

Murder, Medicine and Motherhood

Since the early 1990s, unexplained infant death has been reformulated as a criminal justice problem within many western societies. This shift has produced wrongful convictions in more than one jurisdiction. This book uses a detailed case study of the murder trial and appeals of Kathleen Folbigg to examine the pragmatics of proof beyond a reasonable doubt. It explores how legal process, medical knowledge and expectations of motherhood work together when a mother is charged with killing infants who have died in mysterious circumstances. The author argues that Folbigg, who remains in prison, was wrongly convicted. The book also employs Folbigg's trial and appeals to consider what lessons courts have learned from prior wrongful convictions such as those of Sally Clark and Angela Cannings. The author's research demonstrates that the Folbigg court was misled about the state of medical knowledge regarding infant death and that the case proceeded on the incorrect assumption that behavioural and scientific evidence provided independent proofs of guilt. Individual chapters critically assess the relationships between medical research and expert testimony, the operation of unexamined cultural assumptions about good mothering and the manner in which contested cases are reported by the press as overwhelming.

Victorian Murderesses Naz

Bulamur, 2016-02-08 Victorian Murderesses investigates the politics of female violence in Thomas Hardy's *Tess of the D'Urbervilles* (1891), George Eliot's *Adam Bede* (1859), Mary Braddon's *Lady Audley's Secret* (1862) and Florence Marryat's *The Blood of the Vampire* (1897). The controversial figure of the murderess in these four novels challenges the assumption that women are essentially nurturing and passive and that violence and aggression are exclusively male traits. By focusing on the representations of murder committed by women, this book demonstrates how legal and even medical discourses endorsed Victorian domestic ideology as female criminals were often locked up in asylums and publicly executed without substantial evidence. While paying close attention to the social, economic, judicial and political dynamics of Victorian England, this interdisciplinary study also tackles the question of female agency as the novels simultaneously portray women as perpetrators of murder and excuse their socially unacceptable traits of anger and violence by invoking heredity and madness. Although the four novels tend to undercut female power and attribute violence to adulterous women, they are revolutionary enough to deploy female characters who rebel against male sovereignty and their domestic roles by stabbing their rapists.
