Cette procédure, était organisée par la loi du 17 avril 1995 (les articles 9 à 17) est actuellement régie par les nouvelles dispositions du code de commerce apportées par la loi de 2016 (articles 422 à 432), offre une alternative plus souple et moins coûteuse aux procédures contentieuses de redressement et liquidation judiciaire.

La demande est rejetée si les documents et données sus indiquées ne sont pas présentés sans motif valable. Le rejet n'empêche pas la présentation d'une nouvelle demande.
