Ohio s Rufus P Ranney embodied many of the most intriguing social and political tensions of his time He was an anticorporate campaigner who became John D Rockefeller s favorite lawyer A student and law partner of abolitionist Benjamin F Wade Ranney acquired an antislavery reputation and recruited troops for the Union army but as a Democratic candidate for governor he denied the power of Congress to restrict slavery in the territories and during the Civil War and Reconstruction he condemned Republican policies Ranney was a key delegate at Ohio s second constitutional convention and a two time justice of the Ohio Supreme Court He advocated equality and limited government as understood by radical
