Regulating European Drug Problems Nicholas Dorn, 2023-09-20 Throughout Europe from town halls and regional governments through national Parliaments and ministries to the high institutions of the European Union there runs a vigorous debate on organised crime municipal safety and private conduct Drug problems and what to do about them often occupy center stage at these debates Throughout the 1990s the focus of legal attention has been primarily on the criminal law New criminal offenses have been created partly in response to influences from above from international and European agreements and partly in response to pressure from below concerns of citizens at national and sub national levels But although criminal law certainly is important as far as the development of drug controls is concerned it is by no means the whole story There is a parallel history a regulatory one consisting of the increasing use of administrative measures some of which are directly concerned with drugs while others are more general but equally applicable.
