the UN Charter with primary responsibility for the maintenance and restoration of the international peace it is the only body with the power to authorise military intervention legally and impose international sanctions where it decides. However its decision making process has hitherto been obscure and allegations of political bias have been made against the Security Council in its responses to potential international threats. Despite the rule of law featuring on the Security Council's agenda for over a decade and a UN General Assembly declaration in 2012 establishing that the rule of law should apply internally to the UN, the Security Council has yet to formulate or incorporate a rule of law framework that would govern its decision making process.
