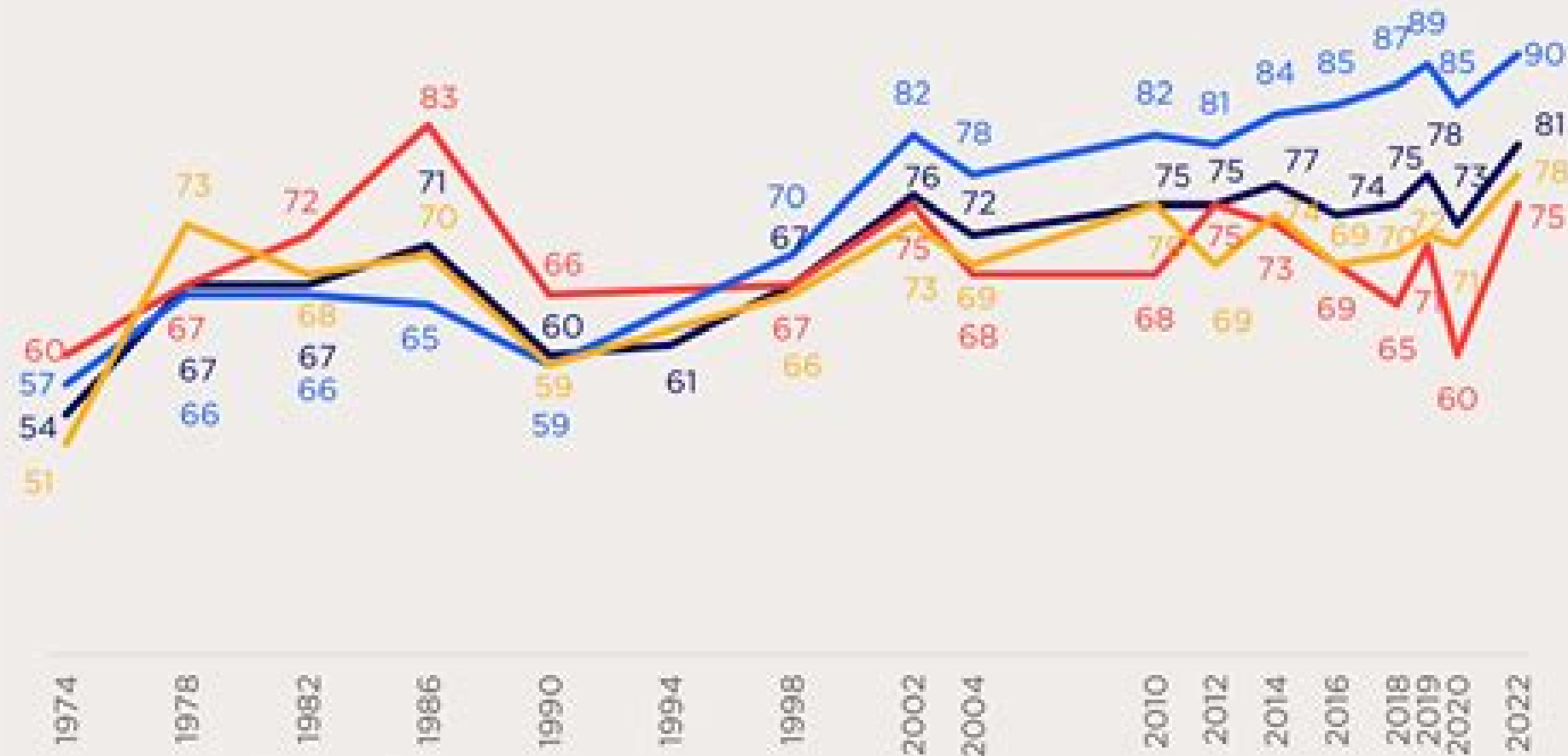


# Figure A: Commitment to NATO
