- \* After Intolerable Acts colonies decided to meet
- Delegates from all colonies except Georgia met at Philadelphia – Sept 1774 – Oct 1774
- Sent a letter called the Declaration of Rights to the King and called for a general boycott of all British goods – and then went home and waited
- King ignored letter
- In the meantime, the Battles of Lexington and Concord are fought on April 19<sup>th</sup>
- Colonies decide to meet again.
