lays bare the reality of friendly judicial review and partisan supremacy when it comes to election law. She nonetheless finds a mixed verdict in the redistricting area that reveals the limits of partisan control over judicial decisions. Peretti's book helpfully places the current GOP's voter suppression campaign in historical context by acknowledging similar efforts by the post-Civil War Democratic Party. While the modern Democratic Party seeks electoral advantage by expanding voting by America's minorities and youth arguably hewing closer to democratic principles, neither party is immune to the powerful incentive to bend election rules in its favor. In view of the evidence that Partisan Supremacy brings to light, we are left with a critical and pressing question: Can democracy survive in the face of partisan collaboration across the branches of government on critical election issues?
