Nakamura, 2001-05-16 The federal Superfund program for cleaning up America's inactive toxic waste sites is noteworthy not only for its enormous cost 15.2 billion has been authorized thus far but also for its unique design The legislation that created Superfund provided the Environmental Protection Agency with a diverse set of policy tools Preeminent among them is a civil liability scheme that imposes responsibility for multimillion dollar cleanups on businesses and government units linked even tangentially to hazardous waste sites Armed with this potent policy implement the agency can order the parties who are legally responsible for the toxic substances at a site to clean it up with large fines and damages for failure to comply EPA can also offer conciliatory measures to bring about voluntary privately financed cleanup or it can launch a cleanup initially paid for by Superfund and later force the responsible parties to
