**Simplifying algebraic expressions** is when we use a variety of techniques to make algebraic expressions more efficient and compact – in their simplest form.

 **Example** Simplify  $8x + 4 + 3(2x - 3)$

**1** Expand the brackets  $8x + 4 + 3(2x - 3) = 8x + 4 + 6x - 9$

**2** Collect like terms  $8x + 4 + 6x - 9 = 14x - 5$

The simplified expression is  $14x - 5$
