manipulation's presumptive immorality derives from the fact that it involves getting someone to make a mistake and making a mistake is a bad thing. However, the most morally egregious instances of manipulation also have bad effects on well-being and autonomy. This book concludes by applying the Mistake Account to various influences including priming, conditioning, nudges, advertising, sales, and online influences.
