and legal background to the cases and an analysis of the position in England of black servants slaves brought to England and the legal effects of the cases taking into account the new information provided by the transcripts There was a conflict in legal authorities as to whether black servants remained slaves or became free on arrival in England Lord Mansfield the chief justice of the court of King's Bench was a central figure in all the cases and clearly struggled to come to terms with slavery The material provides a basis for tracing the evolution of his thought on the subject On the one hand the huge profits from slave production in the West Indies flooded into England slave owners had penetrated the leading institutions in England and the pro-slavery lobby was influential On the other hand English law had over time established rights and liberties which in the 18th century were seen by many as national characteristics That tradition was bolstered by the ideas of the Enlightenment By about the 1760s it had become clear that there was no property in the person and by the 1770s that such servants could not be sent abroad without their consent but whether they owed an obligation of perpetual service remained unresolved
