The Soviets had borne the brunt of the fighting against Germany, and their almost unimaginable suffering gave them moral authority. They would not be denied a place on the tribunal, and moreover, were determined to make the most of it. However, little went as the Soviets had planned. Stalin's efforts to steer the trials from afar backfired. Soviet war crimes were exposed in open court. As relations among the four countries of the prosecution foundered, Nuremberg turned from a court of justice to an early front of the Cold War.
