#1 WHAT IS IT?



An employer-sponsored plan where contributions are with after-tax dollars.



A type of retirement account that you set up on your own. After-tax dollars are added to the account directly by the account owner.

#2 INCOME LIMITS?



No income limits to contribute.



Cannot contribute if Modified Adjusted Gross Income is equal to or above \$144,000 for single filers and \$214,000 for Married Filing Jointly (for 2022).

#3 2023 CONTRIBUTIONS?



\$22,500 if you are under 50, and \$30,000 if you are 50 or older (for 2023).



\$6,500 with an additional \$1,000 catch-up contribution (\$7,500 total) if you're over 50 or older (for 2023).

#4 REQUIRED MINIMUM DISTRIBUTIONS?



Subject to required minimum distribution rules. However, starting in 2024, RMDs will no longer be required.



RMDs are not required.

#5 EARLY WITHDRAWALS?



If the plan allows, you can access your contributions tax and penalty-free. Withdrawals are pro-rated, a portion will be treated as an early withdrawal of earnings and may be subject to income tax and 10% tax penalty.



Allowed to take out only your contributions anytime with no penalty and no tax. Early withdrawal of earnings may be subject to taxes and a 10% penalty.
