In this volume, a third solution is proposed. The idea is presented that many equitable principles may qualify as general principles of law recognised by civilised nations, one of the three principal sources of international law, though a category that is often overlooked. Transconstitutionalism does not take any single legal order or type of order as a starting point or ultima ratio.
