Types of Shares: Share capital may consist of different types of shares, such as ordinary shares, preference shares, or redeemable shares, each with its own rights and characteristics. For example, ordinary shares typically confer voting rights and entitle shareholders to dividends, while preference shares may have priority rights to dividends or assets in the event of liquidation.

Increase or Decrease: Companies may increase their share capital through a process known as capitalization, which involves issuing additional shares to existing shareholders or selling new shares to outside investors. Conversely, share capital can be reduced through processes like share buybacks or capital reduction schemes, subject to legal and regulatory requirements.

Regulatory Compliance: Companies are required to comply with relevant laws and regulations governing the issuance and management of share capital. This includes disclosure requirements, approval procedures, and compliance with corporate governance standards.
