

Further Distortions to Trade – Non-Tariff Barriers

- Non-Tariff Barriers (NTB) proliferate even when standard tariff barriers have been reduced / eliminated
- Examples:
 - Different legal and technical standards between countries
 - Export Subsidies
 - Government procurement policies favouring domestic firms
 - Research and development subsidies
 - Different labour market regulations
 - Language barriers are also effectively a non-tariff barrier – particularly in industries where personal communication is important (e.g. when consumers are buying financial services)
