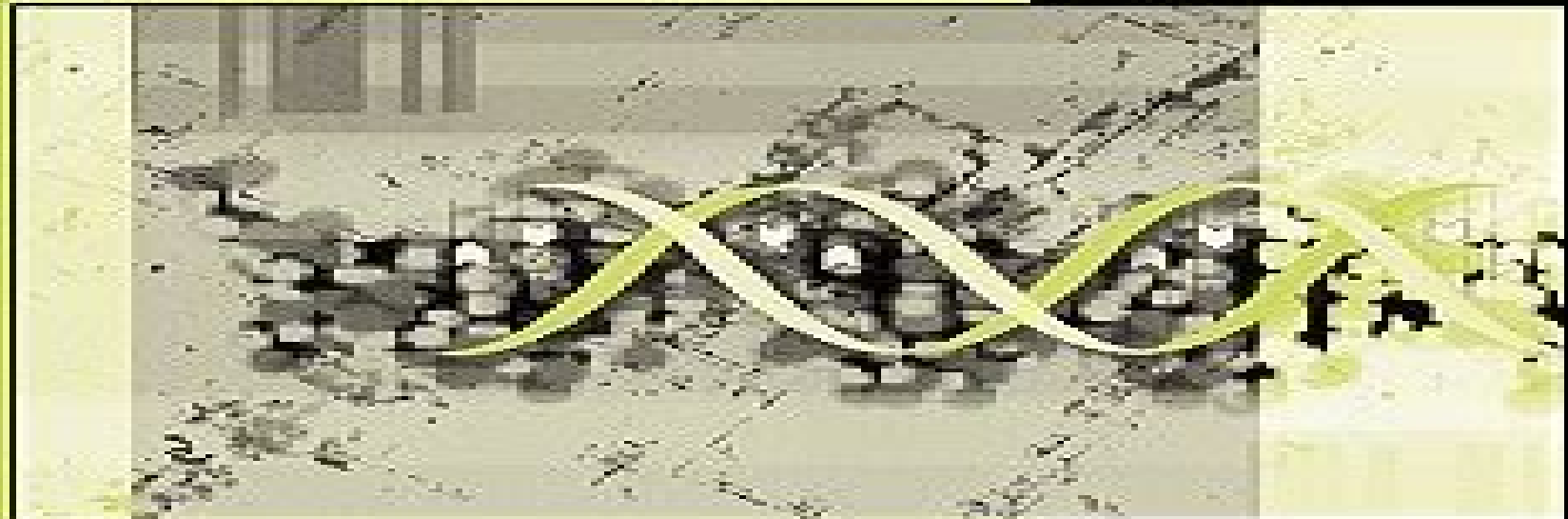

matters relating to reproductive health The popular books TV series and films that touch upon these discussions including *The Handmaid's Tale* and *Mother* strengthen the perception that a more in depth theological and ethical discussion on the theme may be necessary particularly towards exploring stories and confessions from our faith tradition that may provide us with a timely opportunity to do the important work of theological reconceiving
